### PRIVACY POLICY

Chetana Global Foundation is committed to protecting your privacy. Because we understand how important it is that you know what will happen to any personal information you provide, our mission is to adhere to policies that prevent unauthorized use of your personal profile; to maintain the accuracy of the information provided; and to protect the privacy of your data using the best security technologies. We maintain rigorous security and quality controls to ensure that all of our marketing practices meet or exceed industry standards and all State and Federal regulation

Our approach to privacy is simple – we are vigilant about protecting your privacy at all times. Your use of the Website constitutes your acceptance of this Privacy Policy and the Terms of Use. If you do not accept any aspect of the Policy you should not use the Website.

This policy is designed to assist you in understanding what information you may be asked to provide, how the information is used and shared, and how you can control the information via our website [www.chetanaus.org](http://www.chetanaus.org) (aka “Website”). We will not use or share your information with anyone except as prescribed in this Privacy Policy (aka “Policy”).

#### **Information We Ask You to Provide**

If you choose to create an account with us and become a member, you will be asked to select a username and password. We will ask you to provide certain personal information, such as first name, last name, and email address, in creating your user profile. Once created, the user profile will be viewable by the general public. (You may, however, disable this option via your profile settings.) If you donate via the Website, we will also ask you to provide your mailing address for tax-deductible receipt purposes.

We shall have access to all information you submit to the Website.

You may also post information, such as comments, texts, images, videos, and other content (aka “Materials”) to the Website. Any Materials you post to the Website may be viewable by the general public and are governed by our Terms of Use.

#### **Our Use of Information You Provide**

If you create an account with us, we may send a monthly newsletter, system notifications, and other communications to your email. You may opt out of the monthly newsletter by adjusting the settings in your

user account. We will also use the information you submit to the Website to facilitate completion of your donations made via the Website and to provide you with tools to manage and monitor your transactions.

Chetana Global Foundation is an associated independent, tax-exempt nonprofit that is the recipient of all donations that are made through the Website. Chetana Global Foundation maintains one of the largest donor advised funds in the nation, consisting of most US-based public charities in good standing. In furthering its charitable and educational mission of catalyzing grass-roots philanthropy, the Foundation has agreed to serve as the nation's trusted charity facilitator of choice. When you make a donation to Chetana Global Foundation, you grant us (along with Chetana Global Foundation) permission to access your donation records at any time.

If you choose to make your donation anonymously, we will share only the donation amount and your employer (if optionally provided) of the advised and completed re-grant with your selected organization, fundraiser, and/or Giving Event Administrator.

Your information may also be provided to third parties – such as (for example) the credit card company, the sponsoring bank, and/or the bank issuing the credit card – for the purpose of processing the credit card (or other) charitable gift transaction. Should you provide us with information related to a matching gift, your information will be shared with third parties for the purpose of processing the matching gift donation.

Chetana Global Foundation will never share your personal information, donation activity, or email address with any other third party without your prior consent (except as may be required by law).

We will use all the pictures of Volunteering/other activity in our all social media Platform.

We will use your contact information to send you information concerning your donation, including without limitation a donation confirmation and any notices about problems with your debit / credit card.

## **Security**

Chetana Global Foundation takes security seriously and we take reasonable measure to protect our user's information. The debit/credit card information entered while donating on Website is not visible to our foundation. All payments using debit/credit card are processed by PayPal and what you share on our site towards payment is governed under Paypal's privacy policy. We are not, however, responsible for any information you share with other users of the Website or other third parties.

When creating an account and asked to choose a password, in which case your online account information shall be protected by your password. We recommend that you do not disclose your password to any other person. You are responsible for maintaining the confidentiality of your password and account, and are fully responsible for all activities that occur under your password or account

## **Privacy Protection for Children**

This Website is not directed to children under the age of thirteen. In compliance with the Children's Online Privacy Protection Act, we do not knowingly collect personally identifiable information from persons under the age of 13 through the Website or otherwise. If we later learn that any user is under the age of 13, or that we have inadvertently received personally identifiable information from a user under the age of 13 through the Website, we will take appropriate steps to remove that user's information from the database and restrict that user's access to the Website.

Because we do not collect any personally identifiable information from children under the age of 13 via the Website, we also do not knowingly distribute such information to third parties, and we do not condition the participation of a child under 13 in the Site's online activities on providing personally identifiable information.

### **Cookies**
